Chlorine Meter

RC/RW a motion was made and seconded to approve the purchase of a chlorine meter not to exceed \$700. Motion carried 4-0.

Fence Repair

RW/AA a motion was made and seconded to approve the bid from Up-Right Fence to repair the fence around the wastewater treatment plant. Motion carried 4-0.

Department of Retirement Services

Rebecca said the district is eligible for the state retirement plan for employees. There are 2 plans. PERS has an employer and employee contribution. The deferred plan has an employee contribution only. The district would have to become a member to be eligible and a resolution would have to be passed to do so.

Transfer Fee

Rebecca proposed researching what other districts charge for a potential increase in transfer fees in 2024.

Policy Review and Development

Rebecca proposed reviewing and updating current policies, and developing new policies, as needed. One policy will be reviewed at each regular meeting in 2023. January could be a discussion about water leaks and a possible change in fees for water overage to encourage customers to fix water leaks.
